

MOTHERLODE VOLLEYBALL CLUB COVID LIABILITY WAIVER

The novel coronavirus, COVID-19, has been declared a worldwide pandemic by the World Health Organization. COVID-19 is extremely contagious and is believed to spread mainly from person-to-person contact, including individuals without disease symptoms. As a result, federal, state, and local governments and federal and state health agencies recommend social distancing and have, in many locations, prohibited or limited the congregation of groups of people. The health and well-being of our staff and athletes remains our top priority. In order to minimize the risk of COVID19 entering our environment and spreading amongst our community, we will only allow staff assigned to work and athletes scheduled to participate to be in our gym. Parents wishing to remain on site MUST SOCIAL DISTANCE AND WEAR A MASK inside the facility at all times or can use outdoor common areas or the parking lot to wait for their athlete(s). Athletes waiting to attend a session will need to wait outside while maintaining social distance from others. Furthermore, all participants in sponsored activities at MOTHERLODE VOLLEYBALL CLUB must agree to and abide by the following:

1. Participants will alert MOTHERLODE VOLLEYBALL CLUB, immediately of any exposure to or possible infection by COVID19, including themselves, family members, or recent contacts. This includes showing any symptoms (elevated temperature above 100 degrees, cough, shortness of breath, loss of taste or smell, or a positive COVID-19 test).
2. Parents and participants agree that they, their family members, and their known contacts have not shown symptoms within the last 14 days.
3. Participants will follow all protocol put forth by MOTHERLODE VOLLEYBALL CLUB or may be asked to leave. MOTHERLODE VOLLEYBALL CLUB (hereafter referred to as the "Club") has put in place numerous preventative measures and enhanced cleaning protocols to reduce the likelihood of spreading COVID-19 in Club's gym environment; however, the Club cannot guarantee that you or your child(ren) will not become infected with COVID-19. Further, attending sponsored activities at the Club could increase your risk and your child(ren)'s risk of contracting COVID-19.

By signing this agreement, I acknowledge the contagious nature of COVID-19 and voluntarily agree to the participation terms described above and assume the risk that my child(ren) and may be exposed to or infected by COVID-19 by attending Club activities and that such exposure or infection may result in personal injury, illness, permanent disability, and death. I understand that the risk of becoming exposed to or infected by COVID-19 at the Club may result from the actions, omissions, or negligence of myself and others, including, but not limited to, Club employees, volunteers, and program participants and their families. I voluntarily agree to assume all of the foregoing risks and accept sole responsibility for any injury to my child(ren) or myself (including, but not limited to, personal injury, disability, and death), illness, damage, loss, claim, liability, or expense, of any kind, that] or my child(ren) may experience or incur in connection with my child(ren)'s attendance at the Club or participation in Club programming ("Claims"). On my behalf, and on behalf of my children, I hereby release, covenant not to sue, discharge, and hold harmless the Club, its employees, agents, and representatives, of and from the Claims, including all liabilities, claims, actions, damages, costs or expenses of any kind arising out of or relating thereto. I understand and agree that this release includes any Claims based on the actions, omissions, or negligence of the Club, its employees, agents, and representatives, whether a COVID-19 infection occurs before, during, or after participation in any Club activity.
